New Business

New Amendment

- Currently have \$20,000 in surplus since we were not able to hire a Behavior Support Specialist
- Caleb polled teachers for wants and needs
- Will offer teachers an opportunity to work when school is out to do their priority standards, scales, translations for exams, assignments and other items
- Council members agreed that funding teachers for their work when school is out, would be beneficial to students, now and in the future
- Created for Goal#2, Action Item D:
 - Fund professional prep days, paid at teachers' daily rates: to write and update Priority Standards; aligned lesson plans with an emphasis on Tier One interventions; write Common Formative Assessments; translate assessments and assignments, and update Priority Standards and Scales.
 - Funding amount to be assigned: \$20,000
- Caleb made the motion to add the new amendment with the reassignment of funds for this year's school improvement plan.
- Kim Abbott seconded the motion, all present in favor of motion.

2022-2023 School Improvement Plan

- On April 1st, we need to send our next year's plan in for Board members to vote on
- We have increased our % on Goal#2
- We currently haven't reached Goal#4
- We will continue to work towards the goals
